Who are we?

What are you going to do?

As a (Sr.) Clinical Research Associate (CRA), you have an important role in setting up, supervising and coordinating clinical research. You will do this under the supervision of the Project Manager and within a diverse project team.

Because you will participate in national and international projects, you sometimes will have to travel. Within the different countries in which the studies are executed, there will be local CRAs assigned to the studies working with you. Depending on your level of experience, you will be asked to manage the country-based CRA's together with the Project Manager.

At Cardialysis you will find passionate colleagues who want to work with you on new developments. Within Cardialysis you can develop yourself broadly as a CRA. - Knowledge of ICH-GCP and preferably also of ISO14155, MDR and CTR.
- A completed (bio)medical education either at university level or university of applied sciences level (at least a Bachelor degree, a Master's degree is preferred).
- A results, solution oriented and professional attitude, being proactive and flexible.
